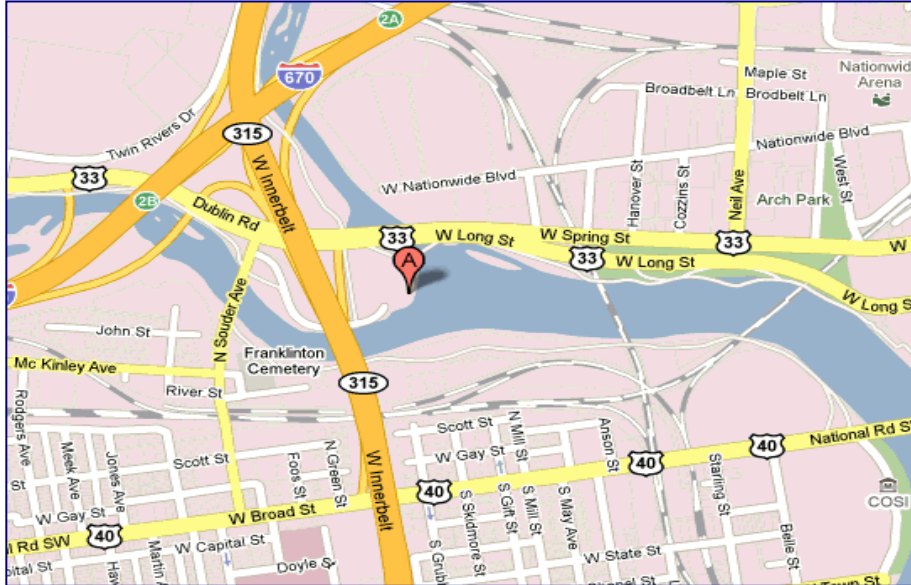

I-71 South

Follow 71 North to 315 North/Exit Dublin-Long Street/Turn Left onto Souder Avenue/Immediately Turn Left onto Rickenbacker/Follow Driveway into our Parking Lot
